November 2012 Post-Election Wrap-Up

November 6, 2012, Americans headed to the polls and voted for an essentially "status quo" Federal government; with Democrats continuing to control the White House and the Senate, and Republicans controlling the House of Representatives. While much of the current talk surrounds the fiscal cliff issue, we continue to promote and look for opportunities for inclusion or enactment of H.R.2866/S.1526, the Mechanical Insulation Installation Incentive Act (MIIIA), before Congress adjourns at the end of the year, marking the end of the 112th Congress.

The National Insulation Association (NIA) continues to push strongly for action in the remaining weeks of 2012, as we lost numerous cosponsors of H.R. 2866 in the House of Representatives through retirement, election loss, or sponsors running for another office. These members include:

This represents 13 losses of the current 77 MIIIA cosponsors for this year in the House. However, both Mazie Hirono (D-HI) and Joe Donnelly (D-IN) were elected to the Senate and hopefully will continue their support of mechanical insulation when they are sworn into office in early January. All five Senators cosponsoring MIIIA remain in office for the next term.

In other news, you may remember reading in the September 2012 edition of the *Insulation Advocate* that we finalized the last component of the Mechanical Insulation Education and Awareness Campaign (MIC). NIA printed three marketing flyers promoting the simple calculators, commercial and industrial data, and E-Learning modules (*www.nterlearning.org*). Included in each NIA members' 2013 dues invoice mailing was a complimentary copy of each flyer and an order form entitling NIA members in good standing (2013 membership dues paid) to an additional 25 complimentary copies of each flyer.
