- Have successfully completed the online [Mechanical Insulation Basics course](#) and the Part 1 of this course known as [Understanding Mechanical Insulation](#) resulting in an initial understanding of the principles and fundamentals of insulation and insulation systems, types of insulation products, mechanical insulation science and technology, maintenance, and more. The fee for this course is included as part of the registration fee, and a link to take the On Demand courses will be sent to attendees after registering for the course;
- A minimum of 3 years of experience in commercial and/or industrial construction, process, and maintenance industry, inspection, or related fields;
- The ability to work in a team environment; and
- The ability to recognize potential basic safety concerns during facility visits and insulation system inspections.
